1 All reference in this application to 'Piraeus Bank' the 'Bank' the 'branch' the 'group,' and corresponding references to 'we,' 'our,' and in this Declaration 'you,' shall be read and understood by me/us as references to Piraeus Bank S.A its subsidiaries, associated and affiliated companies and any person or body which has had Piraeus Bank's rights transferred to them, or has succeeded to those rights (whether directly or indirectly) to the extent of your or their respective rights and benefits.

2 I/We confirm that I/We am/are over 18 years old and that the information given and statements made by me/us or on my/our behalf are true and complete to the best of my/our knowledge and belief. They shall form the basis on which any loan is granted.

3 If any of the information changes before the loan is made I/we will notify you in writing and will not take up the loan unless you have previously agreed in writing to such a change.

4 If any information is inaccurate or if I/we do not fully answer any question then Piraeus Bank may refuse to proceed, or where the loan has already been made. Piraeus Bank may demand repayment.

5 You may apply to my/our present or past employer(s), lender(s), check my/our accountant(s), solicitor(s), estate agent(s), landlord(s), banker(s), and insurer(s) or any other party who I/we authorise to provide any information relevant to my/our application.

6 You may supply to my/our present lender(s) any information relevant to my/our application.

7 I/We will provide any information regarding my/our financial position or the property as you may reasonably require, at any time.

8 I/We am/are responsible for your legal and other expenses arising out of this application, whether or not a loan is granted or the mortgage completed. I/We authorise you debit my/our current account with the expenses.

9 The security for the loan will be a first legal charge over the property to be purchased.
